Lawrence County School Board Meeting

June 13, 2016

The Lawrence County Board of Directors met in regular session on Monday, June 13, 2016, in the board room of the Superintendent's Office. Vice- President Ron Ingram called the meeting to order and Clay Sloan offered the prayer. John Householder was not in attendance.
